The U. S. District Court is located in the Birch Bayh Federal Building and U. S. Courthouse. The building encompasses a square block and is surrounded by Ohio, Meridian, New York, and Pennsylvania Streets. The building faces Ohio Street and is directly across from the tallest building in downtown Indianapolis (the Chase Tower). Be aware that New York is “one-way” eastbound and Pennsylvania is “one-way” southbound.

From the North: Take I-65 South toward downtown Indianapolis to the Meridian Street exit. Turn right on Meridian Street. Continue on Meridian Street to Ohio Street (located just one block north of Monument Circle). Turn left onto Ohio Street and the courthouse is on your left. Parking can be found at any parking garage on adjoining streets. (See enclosed map for parking in the area)

From the South: Take I-65 North toward downtown Indianapolis, staying in the right lanes. (I-65 splits just before the downtown area and I-70 will veer to the left (heading toward Chicago and St. Louis). Stay to the right on I-65, (heading toward Columbus, Ohio). Take the Washington Street exit (Exit #111). Turn left onto Washington Street/US-40 W. Proceed on Washington Street to Delaware Street. Turn right on Delaware Street and proceed to Ohio Street. Turn left on Ohio Street, proceeding through the first block. The courthouse is located on the right in the second block. (See enclosed map for parking in the area)

From the East: Take I-70 West to the I-65 South split (on the left) toward downtown Indianapolis. Merge onto I-65 South/I-70 West via exit 83A toward Michigan St/Ohio St/Fletcher Avenue. Take the Ohio Street exit. After making a slight right onto Ohio Street, proceed to the courthouse (about .6 miles), which is located on the right, just after passing Pennsylvania Street. (See enclosed map for parking in the area)

From the West: Take I-70 East towards downtown Indianapolis. Exit at Illinois Street/McCarty Street (Exit 79B). Bear left at the split on the exit ramp, merging onto Illinois Street (one-way, heading north). Follow Illinois Street north about 9 blocks to Ohio Street. Turn right onto Ohio Street. The courthouse is located one block ahead, on the left side of the street, after passing through the Meridian Street intersection. (See enclosed map for parking in the area)

**PARKING**

Below is a list of convenient parking lots for jurors. The enclosed map also indicates various parking locations throughout the downtown Indianapolis area. Parking rates may vary.

One Indiana Square Garage:

150 E. Ohio Street – Located at the Regions Bank on the corner of Pennsylvania and Ohio Street, across from the courthouse on the Pennsylvania Street side. The entrance is located on Ohio Street. The parking rate is \$4.00 for the first hour and the daily maximum is \$12.00. Parking is available for 24 hours.

Chase Tower Garage:

120 N. Pennsylvania Street – Located at the Chase Tower on the corner of Pennsylvania and Ohio Street, across from the courthouse on the Ohio Street side. The entrance is located on Pennsylvania Street. The parking rate is \$7.00 for the first hour and the daily maximum is \$17.00. The hours of operation are 5am – 12am on weekdays and 8am – 11pm on Saturday.

Express Park Garage:

20 N. Pennsylvania Street – Located in between Market Street and Ohio Street, on the same side as Chase Tower. The parking rate is \$3.00 for the first hour and the daily maximum is \$9.00. The hours of operation are 6am – 12am on weekdays, 24 hours on Saturday, and 12am – 6pm on Sunday.

**Please remember: Do not park at a parking meter. You will not be reimbursed for parking citations.**
