FILING A CIVIL ACTION, SUIT, OR PROCEEDING (whether by original process, removal, or otherwise) *The \$400 filing fee includes a \$50 administrative fee, consistent with item 14 of the District Court Miscellaneous Fee Schedule appended to 28 U.S.C. § 1914. The administrative fee does not apply to applications for a writ of habeas corpus or to persons granted in forma pauperis status under 28 U.S.C. § 1915.	\$400.00*

REPRODUCTION OF A PAPER RECORD (per page) (This fee applies to paper copies made from either: (1) original documents; or (2) reproductions of original records. This fee applies to services rendered on behalf of the United States if the record or paper requested is available through electronic access.)	\$.50
REPRODUCTION OF AN ELECTRONIC RECORD (For reproduction and transmitting in any manner a copy of an electronic record stored outside of the court's electronic case management system, including but not limited to, document files, audio recordings, and video recordings, the fee is \$31 per record provided.)	\$31.00
REPRODUCTION OF AN AUDIO RECORDING OF A COURT PROCEEDING	\$31.00
RETRIEVAL OF RECORD FROM OFF-SITE STORAGE FACILITY *The fee of \$64 is for the retrieval of <u>one box</u> from a Federal Records Center, National Archives, or other storage location removed from the place of business of the court. For retrievals involving multiple boxes, a fee of \$39 will be charged for each additional box.	\$64.00*
ELECTRONIC RETRIEVAL OF RECORD *The fee of \$19.90 is the fee for the <u>electronic retrieval</u> of a record from a Federal Records Center, National Archives, or other storage location removed from the place of business of the court. A per page fee of \$.65 will be charged in addition to the standard fee.	\$19.90*
