## NOTICE OF FEE INCREASES, EFFECTIVE DECEMBER 1, 2023

At its March 2023 and September 2023 sessions, on the recommendation of the Committee on Court Administration and Case Management, the Judicial Conference approved inflationary adjustments to fees on the appellate, district, and bankruptcy court miscellaneous fee schedules, as well as on the Court of Federal Claims and the Judicial Panel on Multidistrict Litigation miscellaneous fee schedules pursuant to 28 U.S.C. §§ 1913, 1914, 1930, 1926, and 1932, respectively. These changes are scheduled to become effective **December 1, 2023**.

The updated District Court Fee Schedule (issued in accordance with 28 U.S.C. § 1914) is attached to this Notice. (Of importance, please note specific fee increases to the following: civil filings, miscellaneous filings, apostilles, records search, document certification, document exemplification, copies of electronic records (stored outside of CM/ECF), copies of audio recordings, retrieval of records stored off-site (and electronic retrievals), appeals for a magistrate judge misdemeanor case, attorney admission, and copies of a certificate of good standing, etc.)

FILING A CIVIL ACTION, SUIT, OR PROCEEDING (whether by original process, removal, or otherwise)  *The \$405 filing fee includes a \$55 administrative fee, consistent with item 14 of the District Court Miscellaneous Fee Schedule appended to 28 U.S.C. § 1914. The administrative fee does not apply to applications for a writ of habeas corpus or to persons granted in forma pauperis status under 28 U.S.C. § 1915.	\$405.00*

RETRIEVAL OF RECORD FROM OFF-SITE STORAGE FACILITY  *The fee of \$70 is for the retrieval of <u>one box</u> from a Federal Records Center, National Archives, or other storage location removed from the place of business of the court. For retrievals involving multiple boxes, a fee of \$43 will be charged for each additional box.	\$70.00*
ELECTRONIC RETRIEVAL OF RECORD  *The fee of \$20.90 is the fee for the electronic retrieval of a record from a Federal Records Center, National Archives, or other storage location removed from the place of business of the court. A per page fee of \$.65 will be charged in addition to the standard fee.	\$20.90*

All other CRIS Registry Funds: Annual rate of 10 basis points (10%) of assets on deposit shall be assessed from interest earnings.
