Mr. Pritt's claims against Wexford, Nurse Delk, Nurse Davis, Nurse Courtney, Dr. John, Dr. Falconer, Dr. Johnson, and Megan Miller shall proceed. The clerk is directed pursuant to Fed. R. Civ.
