He filed this civil action alleging that various Wabash Valley officials violated his constitutional rights. Mr. Snow has filed a complaint and a motion to amend. Because the motion to amend does not attach a proposed amended complaint, that motion, dkt. 10 , is denied without prejudice. Because the plaintiff is a "prisoner," this Court has an obligation to screen the complaint before service on the defendants: (SEE ORDER). This summary of claims includes all viable claims identified by the Court. All other claims have been dismissed. If the plaintiff believes that additional claims were alleged in the complaint, but not identified by the Court, he shall have through May 17, 2023, in which to identify those claims. The clerk is directed to terminate Brown, Richardson, Pope, Ellis, Centurion Health, Crichfield, and Gardner as defendants on the docket. The clerk is directed to issue process to defendants in the manner specified by Rule 4(d). Process shall consist of the complaint, dkt. 1 , applicable forms (Notice of Lawsuit and Request for Waiver of Service of Summons and Waiver of Service of Summons), and this Order. The clerk is directed to serve the Indiana Department of Correction and Centurion employees electronically.
